- Mobile top-up.
- · Batch transfers.
- Loan information.
- Payroll services.
- · Virtual accounts.
- Account sweeping (sweep in/ sweep out/sweep balance).

Requirements and Procedures

Corporate Internet Banking registration mechanism:

- · The customer shall have a savings or current account at Bank Sahabat Sampoerna.
- The customer registers at Bank Sahabat Sampoerna branch.
- The customer provides an e-mail address to receive transaction information.
- The account registered for Internet Banking must be "Active."
- Hard token and mailer PIN are collected at the Bank Sahabat Sampoerna branch, where the customer applies for the internet banking facility.

Corporate Internet Banking closing mechanism:

- The customer can apply for the termination of the internet banking service.
- Besides the customer's request, Internet Banking services may be closed because accounts are used for unlawful activities.
